**PRECAUTIONARY ACTION FOR THE NATIVE VILLAGE OF
TUNTUTULIAK
EFFECTIVE 03/19/2020
(AMENDED 09/08/2021)**

FOLLOWING THE PRECAUTIONARY GUIDELINES THE VILLAGE OF TUNTUTULIAK IS ON LOCKDOWN UNTIL FURTHER NOTICE AND THE GUIDELINES BELOW SHOULD BE FOLLOWED BY EVERYONE RESIDING OR ARRIVING INTO TUNTUTULIAK

1. After considering daily new cases the group has decided to allow limited public gatherings. Everyone is required to wear masks in any public place or gathering regardless of being vaccinated.
2. Local churches will be in service under the discretions of the church leaders but following social distancing procedures.
3. **Travel: Unvaccinated** residents that travel will need to quarantine for 10 days or may choose a 7 day quarantine if they have a negative test result on day 7.

Vaccinated residents that travel will need to wear masks in public, self-monitor for symptoms, and get a COVID test at the clinic 5-7 days after arriving.

4. **QUARANTINE:** When there is a positive person in a household everyone, regardless of vaccination status, will quarantine. When the positive person has been cleared from COVID fully vaccinated individuals can get off of quarantine after getting a negative test result. Unvaccinated individuals are required to quarantine an additional 10 days starting from the day of the positive person's clearance date.

Not following quarantine protocols: 1st Offence – Warning. 2nd Offence – Individual (along with parents if he/she is a minor) will meet with the Tuntutuliak Tribal Court. 3rd Offence – Will be fined in the amount of \$100.00.

5. Parents are encouraged to have their children play only within the vicinity of their homes for their safety.

6. Anyone that is sick (coughing, sore throat, fevers) are to stay home to prevent the spread of the flu/virus and are encouraged to get tested for COVID.
7. Non-residents and essential workers (LKSD, TCSA Contractors, etc.) who plan on coming to Tuntutuliak need to provide a negative test result to the COVID-Cop or the Cares Coordinator before coming to the village. Call 907-256-6186 for details.
8. As a reminder ALCOHOL, including manufacturing HOMEBREW, and other DRUGS are prohibited within the Native Village of Tuntutuliak as it is a dry village. This is for the health and safety of our community members.
9. In the event of a positive case in Tuntutuliak emergency lockdown will be in effect immediately until further consideration.

*On August 23, 2021 the FDA approved the first COVID-19 vaccine Pfizer. FDA approved its use for everyone 16 years of age and older and still remains available under emergency use for those between the ages of 12-15.

*With the cases rising at an alarming rate in the delta, all residents 12 and older are urged to get vaccinated for the safety of the community. Call the clinic to make an appointment.

* When going to the Stores children should not be following because they are left unattended and tend to play with other children outside the stores. The current COVID strain is mainly effecting children all across the delta including Tuntutuliak.
